# Development Plan PD 59-23 Planning District By-law 2-2023

PD 59-23 By-Law 2-2023 @ 10:00 am.

6408673 Manitoba Inc. has applied to amend the Portage la Prairie Planning District Development Plan to redesignate lot as shown on the attached By-Law. The amendment will change the designation of 15 13<sup>th</sup> Street SW / Lot 181 Plan 15, Parish of Portage la Prairie, from 'Neighbourhood Policy Area' to 'Downtown Corridor Policy Area'.

Due to Saskatchewan Avenue's new design, parking stalls at the front of the applicant's restaurant have been reduced, and they would like to turn the property into a surface parking lot.

The application has been circulated to the Province with no objections being expressed by the Municipal & Northern Relations Community Planning.

The application has also been advertised in the Herald Leader Press for two consecutive weeks as well as public notices have been sent to all owners of property within a 100-meter radius of the proposed development as per Clause 168 of the Planning Act.

**First Reading** of this By-Law was given on October 19, 2023 to commence the process as defined in the Planning Act in considering this application.

As of this writing, we have not received any written objections to the proposed redesignation scheme.

The Proponent, Rob McMillin attended the meeting and answered questions.
