VI. By-Laws

Development Plan PD 52-21 Planning District By-law 1-2021

BE IT RESOLVED THAT the Board move into Hearing for the Development Plan Amendment PD 52-21 By-law 2-2021.

6844406 Manitoba Ltd. has applied to amend the Portage la Prairie Planning District Development Plan to redesignate lots as shown on the attached By-law. The amendment will change the designation on Lot 1 Plan 1817, Rural Municipality of Portage la Prairie from 'Agricultural Policy Area' to 'Commercial/Industrial Policy Area'.

After second reading of the Development Plan By-Law Amendment, the Board must submit the By-law to the Minister for approval as per clause 47(1) of the Planning Act.

The application has been circulated to the Province with no concerns being expressed at time of writing. The Community and Regional Planning office recommend approval.

The application has been advertised in the Herald Leader Press for two consecutive weeks as well as public notices have been sent to all owners of property with a 100 metre radius of the proposed development as per Clause 168 of the Planning Act.

First Reading of this By-law was given on October 21, 2021 to commence the process as defined in the Planning Act in considering this application.

As of this writing, we have not received any written objections to the proposed re-designation scheme.

The applicants, Jaiinder and Satbir Sandhi attended and made a verbal presentation to the Board.

Emails were received from Janet Martin with disapproval of the application for on December 8, 2021; however her email was sent to our quarantine page and was not received in time for the Hearing. The email is attached to this report.

Darryl Mutcher and Wasiq Ralzar were in attendance for the meeting. Neither made a representation but they were in support of the Development Plan Amendment.
