# Development Plan PD 34-21 Planning District By-law 1-2021

#### BLIGHT / FERRIS

Greg Hamilton has applied to amend the Portage la Prairie Planning District Development Plan to redesignate lots as shown on the attached By-law. The amendment will changed the designation of Lot 1 Plan 68067, Rural Municipality of Portage la Prairie from 'Agricultural Policy Area' to 'Neighbourhood Policy Area'.

After second reading of the Development Plan By-Law Amendment, the Board must submit the By-law to the Minister for approval as per clause 47(1) of the Planning Act.

The application has also been advertised in the Herald Leader Press for two consecutive weeks.

First Reading of this By-law was given on May 20, 2021 to commence the process as defined in the Planning Act in considering this application.

Second Reading of this By-law was given on July 15, 2021 and forwarded to the minister for approval.

Minister approved this By-law on September 28, 2021 with the following conditions:

- a) Increased complaints related to noise and odour due to the adjacent industrial area will need to be addressed. This should be done as part of the future zoning and subdivision approvals on the property. Please ensure that the effects of the adjacent industrial area are mitigated through site design requirements and recognized in a development agreement with the Municipality; and
- b) Concerns regarding drainage, increased traffic and sewer and water capacity should also be addressed at that time.

BE IT RESOLVED THAT the Board of Portage la Prairie Planning District approve the application to re-designate the land legally described as Lot 1 Plan 68067, Parish of Portage la Prairie from 'Agricultural Policy Area' to 'Neighbourhood Policy Area' with the condition that the applicant enter into a Development Agreement with the Rural Municipality of Portage la Prairie to address the conditions listed by the Province and THAT By-Law 1-2021 be read a third time, finally passed, signed and sealed.
